INFORMATION ON THE PROCESSING OF PERSONAL DATA

If you agree to participate in the Competition:

Porsche will process your personal data within the following scope:

- identification details name, address
- contact details e-mail address, mobile phone number
- information about your occupation
- date of birth and age

We will keep your data for the duration of the Competition and 18 months thereafter unless you win the Competition.

If you win the Competition:

Porsche will process your personal data within an additional scope:

- needed for handover of the prize and conclusion of a respective Contract, which may include primarily the mileage of the car, dates of the free rent of the car and number of the ID card/passport/driving license,
- photographs and any video or audio recordings taken during the prize handover.

If you win the Competition, we will process your data for the duration of 3 years after the end of Competition.

Personal data will be processed for the purposes of organizing the Competition, assurance of fair draw, informing the public about the results of the Competition and contacting you if you win the Competition. These data can be processed because they are necessary for assurance of a due process of the Competition and compliance with the rules of the Competition, which you have agreed with.

All of the personal data mentioned above will be received from you. You will not be a subject to a decision—making based solely on automated processing of your personal data.

In connection with the processing of personal data, you acknowledge that you have the following rights:

- The right of access to personal data (i.e., the right to be told what personal data Porsche processes about you, what are the purposes of processing, the period for which the personal data will be stored),
- the right to rectification of inaccurate or incomplete personal data (i.e., the right to have your personal data rectified or completed if it has been incorrectly captured for the above purposes),

- the right to erasure personal data in the event of the termination of the purpose or unlawful processing or when they are no longer needed (i.e., the right to have your personal data deleted by Porsche to the extent appropriate in justified cases),
- the right to data portability (i.e., the right to have your personal data provided to another physical or legal person upon your request),
- the right to request restriction of processing (i.e., when the processing is unlawful and you oppose to the erasure, or when you contest the accuracy of personal data),
- the right to lodge a complaint with a supervisory authority available at www.uoou.cz/en, Office for Personal Data Protection, Pplk. Sochora 27, 170 00 Prague 7, the Czech Republic.

As part of the disclosure of personal data to Porsche sales organization network, personal data may be transferred to a third country, under standard contractual clauses, based on the country of prize handover.

The provided personal data may also be disclosed to our business partners providing services to us in connection with the technical aspects of the Competition and to other service providers in this area, as processors or as sub-processors, only to the extent necessary to provide the services in question.

Upon request, your personal data can be provided to public authorities, in particular to police or courts to the necessary extent in accordance with the law.
